Alderwoman Wells asked if there was a correction in administration 2B on the 4<sup>th</sup> page which states that no 3<sup>rd</sup> party contractor shall have the authority to issue citations and that those citations shall issue or should it be shall be issued. Attorney Frye said it should be shall issue. Alderwoman Wells said that on page 3 under 9 the 2<sup>nd</sup> line it says shall be deemed ad admission and is this correct. Attorney Frye stated that it should be and admission.
