Public Hearing on Ordinance 2014-011 at 6:16 p.m. City Attorney Paul Frye read the ordinance which Amends the Bluff City Code Title 18 Dealing with Water/Sewer Adjustments. There were no comments. Hearing closed at 6:17 p.m. Motion to approve on second reading was made by Vice Mayor Harrington. Second by Alderman Bowling. All in favor. Motion carried.

Public Hearing on Ordinance 2014-012 at 6:18 p.m. City Attorney Paul Frye read the ordinance which Amends Section 17-111(1) of the Bluff City Municipal Code Regarding Garbage Collection Fees increasing it to \$10.50 per month. There were no comments. Hearing closed at 6:19 p.m. Motion to approve was made by Alderman Harmon. Second by Vice Mayor Harrington. All in favor. Motion carried.

Discussion / Action on quote to purchase and install a 1720E Turbidimeter at the water plant as mandated by TDEC. City Manager Dulaney stated that this was an item that was on the Sanitary Survey and had to be immediately taken care of. Ms. Dulaney stated that this was the cheapest quote and the total was \$3,645.00. Motion to approve was made by Alderman Carrier. Second by Alderman Harmon. All in favor. Motion carried.

Discussion/Action to accept bids on the water tank maintenance as mandated by TDEC. Alderman Harmon asked if the grant had been approved to help with the cost. Ms. Dulaney stated that they would have to go through this process whether they got the grant or not, but this won't be until October and we hopefully will have the money by then but they need to start the bid process. Motion to start the bid process was made by Alderman Carrier. Second by Vice Mayor Harrington. All in favor. Motion carried.

Citizen Comments - Second Section:

David Smith of 200 Highland Circle asked if when the people do the tank, would they be responsible for any leaks down the road. City Manager Dulaney stated, no they would not.

With no other business, Motion to adjourn was made by Alderman Bowling. Second by Alderman Harmon. All in favor. Meeting adjourned at 7:20 p.m.
