Minutes Bluff City Board of Mayor and Aldermen Regular Meeting July 3, 2018

Mayor Wells called the meeting to order at 6:00 p.m.

Mayor Wells opened the floor for the following:

Citizen Comments – First Session

Amy Vance of 404 Cherokee Dr, stated that they should have received a letter from her and her neighbors and stated that they are still having a bad problem with speeding in their area. Ms Vance asked that this be addressed. She recommended speed humps.

Jack Stratton stated that he is familiar with the area and it is bad there.

Discussion / Action – Minutes for Special Called Meeting June 11, 2018

Motion to approve was made by Vice Mayor Harrington. Second by Alderman Bowling. All in favor. Motion carried.

Discussion Action – Minutes for the Special Called Meeting June 27, 2018

Motion to approve was made by Alderman Bowling. Second by Vice Mayor Harrington. Vote was as follows: Alderwoman Madison – No, Alderman Stratton – Yes, Vice Mayor Harrington – Yes, Alderman Smith – Yes, Alderman Bowling – Yes. Motion carried.

Discussion / Action - Bristol/Bluff's Rate Structure for July 2018- June 2019

CMFO Sharon Greene reported that the rate structure for minimum bill from 0 – 500,000 gallons would be \$1,550.00 – 500,001 – 1,000,000 gallons - \$2.90 per 1,000 gallons – above 1,000,000 gallons - \$2.70 per 1,000 gallons. This rate is for one year then they could address it next year. Alderman Bowling asked what the old rates were. Ms Greene stated it was approximately \$3.50 (per thousand) this year. Motion to approve the rate for one year was made by Alderman Smith. Second was made by Vice Mayor Harrington. All in favor. Motion carried.

Report from Mayor Wells

Mayor Wells reported that she had received the approval to hire a backhoe operator and a water plant operator. She has interviewed 3people for the water plant and 2 wanted \$50 per hour and the one she recommends charges \$26.50 per hour. Motion to approve was made by Vice Mayor Harrington. Second by Alderman Smith. All in favor. Motion carried.

Mayor Wells reported that the backhoe operator is a 25 year veteran and he is asking \$18.00 per hour. We would be able to use him as a Building Inspector on residential as well and would only have to use the other Building Inspector on Commercial. Motion to approve was made by Alderman Bowling. Second by Vice Mayor Harrington. Al in favor. Motion carried.

Discussion / Action - Financial Report - Sharon Greene, CMFO

Ms Greene reported the following fund balances as of May 31, 2018: General Fund - \$1,299,570.00, Sanitation Fund - \$30,340.00, Special Police Fund - \$13,060.00, Debt Service - \$103, 560.00, Sinking Fund - \$3,095.00, Water /Sewer Fund - \$664,710.00. Motion to approve was made by Alderman Bowling. Second by Vice Mayor Harrington. All in favor. Motion carried.

Report from City Attorney Paul Frye

Mr Frye reported that updating Building and Property Maintenance Codes will be coming before the board in the near future.

Alderwoman Madison thanked everyone for coming.

Alderman Stratton thanked everyone for coming and asked that everyone work together.

Vice Mayor Harrington thanked everyone for coming.

Alderman Smith thanked everyone for coming.

Alderman Bowling thanked everyone for coming and he wished we had a bigger crowd.


